- 3) The admittance to Level-1 MCQ Test is **purely provisional** subject to confirmation that they satisfy the prescribed eligibility conditions. **Issue of a call letter to the candidate for Level-1 Test will not imply that his or her candidature has been found eligible.**
- 4) **Level-1 MCQ Test is likely to be held on 07<sup>th</sup> FEBRUARY 2025 in Chennai at TCS iON Centres.**
- 5) Exact details regarding the examination centres will be intimated shortly to the **registered email** of the applicants. Applicants are advised to visit the Institute’s website regularly for further updates.
- 6) The original documents will be verified before the next level of the selection process. In case, it is detected that the documents submitted by the candidates are fake or the candidate has suppressed any information which might lead to non-eligibility for the post, their candidature shall be liable to be terminated.
- 7) The Institute shall make efforts to conduct the MCQ Test for different streams that require the same eligibility criteria in different sessions. However, in the event of very few applications for any stream, the Institute might have to conduct Level-1 MCQ TEST for such stream along with other streams, in which case the candidates may have to choose any one of the streams for which they had applied.
