3) The admittance to Level-1 MCQ Test is **purely provisional** and subject to confirmation

that they satisfy the prescribed eligibility conditions. **Issue of a Admit card to the candidate for Level-1 MCQ Test will not imply that his or her candidature has been found eligible.**

4) Level-1 Computer-Based MCQ Test is tentatively scheduled to be held on **06th December, 2025 in Chennai at TCS iON Centre.**

5) The details regarding the exam date and examination centre has been updated in the **IIT Madras recruitment portal (<https://recruit.iitm.ac.in>)**. Applicants are advised to visit the Institute's website regularly for further updates.

6) The Admit card for Level -1 MCQ Test will be sent to the **registered email id of the provisionally selected candidates** tentatively before 25.11.2025.

7) The original documents will be verified before the next level of the selection process. In case, it is detected that the documents submitted by the candidates are fake or the candidate has suppressed any information which might lead to non-eligibility for the post, their candidature shall be liable to be terminated.

8) The Institute shall make efforts to conduct the Level – 1 Computer Based MCQ Test for different posts. However, in the event of very few applications for any posts(s), the Institute might have to conduct Level-1 MCQ TEST for such posts(s) along with other post(s) advertised, in which case the candidates may have to choose any one of the post for which he/she had applied.
