(100 Marks)

PART – B

(80 Marks)

- The Interview/personality test shall be conducted in such a manner that the candidate's suitability for the post is tested, among other things, through academic qualifications, experience, general awareness/knowledge, communication and problem-solving skills, and overall personality, etc.

Scheme of Examination:

Level	Type of Test	Time	Max. Marks	Weightage for final result
Level -1	Computer-Based MCQ Test (100 questions)	Time : 120 Minutes	100 Marks	40 %
Level – 2	Descriptive Test	Time : 90 minutes	60 Marks	30 %
Level – 3	Personal Interview	Time : 30 minutes	40 Marks	30 %

- A minimum of 5X candidates shall be shortlisted (for X number of posts advertised) for the Level-2 Descriptive Test based on their performance in the Level-1 Computer-Based MCQ Test.
- A minimum of 3X candidates shall be called for Personal Interviews based on their performance in Level-1 and Level-2 Tests.

- a) The questions shall generally be on the minimum qualification level
- b) There shall be no negative marking for wrong answers
